# PEPPER SPRAY TRIGGER POUCH

## How to attach and use a Trigger Pouch for MK2 & MK3 Pepper Spray

### Instructions

1. Choose the side and the angle of the the Trigger Pouch on your belt/vest.




2. The Trigger Pouch will be straight (picture B), to change the angle:

• Release the back clips (picture D): press the clip down and push in the opposite direction of the jagged edge.


• Release the screw (picture D), pull belt adapter out (picture E), turn 30 degrees left/right (picture F).

• When the pin enters the hole (picture E), secure the screw.



3. Attach the Trigger Pouch to your belt / vest.

Close the clips on the belt / vest (press the clips down until is locked). Make sure the clip is locked.



### Inserting the Pepper Spray

4. Open the Trigger Pouch

Pull down the safety lock below button a (picture G)

Press both buttons simultaneously to release the top cover

Insert your pepper spray with nozzle facing forward (picture H)

Close the top cover, making sure it clicks, and lock the safety lock (pull up)



### Maintenance

1. Do not clean the Trigger Pouch when a papper spray is in it.

2. The Trigger Pouch should be cleaned after use with pressurized air, damp rag or running water (under tap).

3. Do not cut or make any change to the Trigger Pouch.
